In the interest of time, the Churchill County High School Career and Technical Education Advisory Committee reserves the right to impose uniform time limits of three (3) minutes on each person providing public comment. No action may be taken upon a matter raised under the public comment period unless the matter itself has been specifically included on an agenda as an action item.

7. The Churchill County High School Career and Technical Education Advisory Committee may remove an item from the agenda or delay discussion relating to an item on the agenda at any time.




